  - 1) **3900, 3930 Georgetown Rd. – 2012-MOD-005** Health and Hospital Corp. of Marion County requests modification of the site plan and commitments related to 2007-ZON-026 to modify commitment six (6) requiring a sidewalk to be installed along Georgetown Rd. within three (3) years to instead permit the painting of an eight (8)-ft. wide pedestrian walkway/bike path on existing asphalt, as shown on the site plan submitted to the file, and requiring the construction of a sidewalk within one year if an adjacent property owner on the west side of Georgetown Rd. installs a sidewalk. Current zoning is SU-9. Hearing is 3/15/12, Hearing Examiner. Council District 7. Presenter is David Kingen. Chairperson is Jan Marshall, Vice-President, District VI.
  - 2) **8334 Eagle Crest Ln. – 2012-CPL-801/2012-CVR-801** Bill Shirk requests approval of a replat for 2.267 acres, portion of lot seven (7) of Eagle Ridge to establish one lot, to be known as Replat of Part of Eagle Ridge, Lot 7, with a waiver of the standards for resubdivision, requiring the inclusion of the entire parent tract (3.410 acres), and with a waiver of sidewalks. Variance of development standards to provide for a lot with zero (0) feet of street frontage, without direct access to a public street, and with 95 feet of lot width (public street frontage required with direct access to said street, 150-ft. lot width required).
