IV. REPORT FROM MAYOR'S NEIGHBORHOOD LIAISON-NORTHWEST OUTER REGION

MARY CHALMERS – Mary spoke about Request Indy. City government and city services are moving closer to the community. The Mayors Action Center had over 30000 calls in June. Requests can now be made online (Request Indy). The website has been redesigned and is much better than it had been in the past. When you make a request you can now receive an email for follow-up. Proposed water company sale to Citizens Gas – city personnel still looking for ideas on how the money will be used once the sale has been finalized. There will be lots of road improvements very soon. There will be public meetings to discuss options/ideas. A statement was made from the audience that 79th Street between Michigan and Township Line Road is in worse shape now than before the resurfacing.

VII. LAND USE – NEW PETITIONS

1) 7001 W. 56th St. – 2010-APP-013 Indianapolis Colts, Inc. requests PK-II (Park District) approval to provide for a four tee and two green pitch and putt course, a guard shack and pitch and putt support building and 25 parking spaces, and to provide for the approval of the site plan submitted to the file. Council District 6. Hearing date continued by PTRA to 8/12/10, Hearing Examiner. Presenter is Steve Granner. Chairperson is Mark Jakubovie, Vice-President, District V. – Jim Irsay would like to construct a small golf course as a memorial to his late Mother. City has requested landscaping committed to with a previous petition be completed. Colts organization has agreed to do so. Guard house shown on site plan will also store golf maintenance equipment. No lighting of golf course. Lights on guard house will be down-shielded. Golf course is too small to accommodate large groups, thus no traffic congestion. No driving range.

Golf course is on east side of property with the parking lot to the south. No plans for netting now. May need to install such if golf balls hit vehicles. If determined netting is needed, Colts will file another PK-II approval petition and return to PTRA. Jeff Miller noticed commitments have a time limit not to exceed 15 years. Steve Granner said that was an oversight, commitments run in perpetuity. This will be corrected. Golf course will not be available to the general public. Paul inquired about the possibly of burying power lines. Steve said city, not the Colts organization, would need to discuss with power company. Mark motioned to support with following commitments: site plan as presented, no driving range, no lighting of golf course, guard house lighting will be down-shielded, golf course will not be open to the general public, commitment language will be changed from 15 years to perpetuity. Don seconded. Motion carried with 1 opposition.

At this time the Government Building had a power outage.

2) **5429** Lafayette Rd. – 2010-SE2-002 Fentress Builders, Inc. requests special exception and variance of development standards to provide for religious uses, including a 23.417-foot tall, 5,500 sq. ft. sanctuary, and an off-street parking lot (religious uses permitted by special exception). a) a parking lot with a 9-ft. setback from the proposed right-of-way of Lafayette Rd. (40-ft. setback from the proposed right-of-way required) and, b) with a 4.2-ft. tall freestanding sign (max. 4-ft. tall sign permitted), with a 15-ft. setback from the existing right-of-way of Lafayette Rd. Current zoning is D-A and D-2 (dwelling district). Council District 7. Hearing date continued by petitioner to 8/10/10, BZA II. Chairperson is Jan Marshall, Vice-President, District VI.- discussion about Monica Drive access. Monica Drive residents would prefer no traffic on Monica Drive. A second access is needed for emergency access, particularly fire. It was suggested a gate with a lock box available only to emergency personnel could be installed. After further discussion it was determined a committee should be formed and the petition be continued. A two-week continuance as opposed to a 30day will be explored.

With the power outage, no one was able to review the May and June Board Minutes. Approval was tabled to next board meeting.
