Meeting Minutes 04/10/13

Susan Blair called meeting to order at 7:12 PM.

I. WELCOMING – OPEN REMARKS – INTRODUCTION OF ELECTED OFFICIALS, CITY PERSONNEL

Susan read PTRA's mission statement.

Visitors, board members and ex-officio members asked to sign in at back table. Agendas, copies of the board of directors' roster, PTRA membership forms, on the back table. II. GUEST – MARION COUNTY PROSECUTOR – TERRY CURRY

Terry Curry, Drew Wignal, Heather Kistler, and Annie Curin – Outreach Coordinator, presented information from the Prosecutors' Office.

There are 400 employees and they handle 50,000 to 60,000 cases per year. \$106 million collected for children. They have deposed 2 gangs and have prevented more violence that could have occurred. Guns – Deputy Prosecutor and at Federal Court. Non-fatal shooting team group working together. Violent Crime initiative – target hot spots – suppress, contain and sustain. Cases – Bisard – drags on ... many hurdles ... trial October 2013, Allen County. Southside explosion – complex case ... witnesses ... trial June 2014. Clint asked about the length of time people spend in the Marion County jail. The concern is related to the amount of Marion County dollars being spent. They are trying to work toward other alternatives to help with this. Sentencing laws ... there is a need to overhaul the entire code. There is revised code in the legislature...more levels of felonies. More of an incremental grouping. There are currently 4 levels now, 6 levels are proposed for felonies. Regarding alcohol related issues ... will be more severe penalties that will culminate with the loss of licensing. Regarding the Cover-up graffiti program – a public service from the Prosecutor's Office; currently on hold.
