### VIII. LAND USE - CONTINUED PETITION

1) 3718 West 86<sup>th</sup> St. – 2014--ZON-019 Hassan and Suzanne Mihankhah request rezoning of .7 acre from D-2 to C-5 to provide for commercial uses. Petition amended to a C-3 request. Petitioner is now seeking a C-S zoning classification request. Council District 1. Petition appealed to MDC, hearing continued by petitioner to? Presenter is Hassan Mihankhah. Chairperson is Ed Harper, PTRA Vice-President District II. Mr. Mihankhah amended petition to request C-S with C-1 uses and limited C-3 uses. Commitments: Parking limited to front yard. Ed Harper motioned to support C-S zoning, with C-1 uses. In regard to C-3 uses, suggested a committee be organized and committee authorized to provide C-3 use recommendation. Mark seconded. Motion carried unanimously.

## IX. LAND USE – NEW PETITIONS

- 7602 Michigan Rd. 2014-ZON-053 Jim Whiten requests rezoning of 0.44 acre from C-3 and D-5 to the C-3 classification to permit the entire parcel to be within the same commercial zoning district. Council District 2. Hearing date continued by PTRA to 10/23/14, Hearing Examiner. Presenter is Abraham Murphy. Chairperson is Ed Harper, PTRA Vice-President District II. Petitioner seeking PTRA support. Planning Staff is leaning toward a support recommendation. Don't anticipate any visible changes to the property. Current tenants are: retail gift store; retail granite countertops (no onsite fabrication); third tenant, contractor storage only. Based on previous PTRA conversations, owner decided not to lease to hair salons due to limited parking capacity and septic system. Clint motioned to support with commitments: No hair salon or barber shop facility, no automotive uses, no outside storage. Ed Harper seconded. Motion carried unanimously.
- 2) 6201 Coffman Rd. 2014-UV3-024 Jennifer Cattett & Associates requests a variance of use to provide for the kenneling and training of service dogs (not permitted). Current zoning is I-2-S. Council District 1. Hearing date is 10/21/14, BZA. Presenter is Jennifer and Jack Topham. Chairperson is Clint Fultz, PTRA Vice-President District IV. Request is for training and kenneling of service dogs only. Specifically, service dogs for diabetic patients. Petitioner agreed to limit variance to their business (variance will terminate when property is vacated). Business will not exceed 2400 square feet. Clint motioned to take no position but requested petitioners agree to 2 commitments. Petitioner agreed. Mark J. seconded. Motion carried unanimously.
- 4751 Century Plaza Rd. 2014-UV3-025 Jonesboro Investments Corp. requests a variance of use to provide for a 72-unit, multi-family complex with three, three-story buildings with a clubhouse building and community resource facility (multi-family uses not permitted). Current zoning is C-4. Council District 7. Hearing date is 10/21/14, BZA. Present is Elizabeth Williams. Chairperson is Jan Marshall, PTRA Vice-President District VI. Councilor Lewis will support request. Commitments; no billboards or off premise advertising signs. No cell towers. If funded, petitioner agreed to return to PTRA for review and approval of proposed signage. Jan motioned to support with commitments. Mark N. seconded. Motion carried unanimously.
